



## PRODUCT SPECIFIC LICENSE TERMS

### Sybase® Unwired Platform v2.1.x (all editions, all platforms) ("Program")

IN ADDITION TO THE LICENSE TERMS SET OUT IN THE SYBASE LICENSE AGREEMENT, THE FOLLOWING ADDITIONAL OR DIFFERENT RIGHTS AND ACCOMPANYING OBLIGATIONS AND RESTRICTIONS SHALL APPLY TO THE PROGRAM FOR WHICH YOU HAVE PURCHASED A LICENSE.

The Program may contain or be provided with component software products from both Sybase and third parties. Except as set forth below, use of all components is limited to use in the same manner and capacity for which the Program as a whole is licensed. Additional licenses for Sybase components may be available from Sybase for a fee.

#### I. Definitions

Notwithstanding any language in the Agreement or Exhibit A to the contrary, for purposes of calculating the fees owed for CPU License(s) of the Program, the number of CPUs is equal to the number of Processors or Cores on a Machine.

**II. Applicable CPU Pricing Terms.** Notwithstanding any terms to the contrary in your Order, the following definition of "CPU License" shall govern your use of the Program. "CPU License" means the license fee payable by you for each copy of the Program determined by multiplying the applicable CPU rate specified on the Order by the lesser of (i) the number of processors on the Machine ("CPUs") on which the Program is running, (ii) the number of CPUs partitioned by you for use with the Program, or (iii) the number of the specified subset of CPUs to which the Program is bound or restricted. In the event the number of CPUs on which the Program is running exceeds the number of licensed CPUs, you shall report such increase and pay an additional amount determined by multiplying the incremental processors by the then applicable rate per processor set forth in the Price List.

#### III. Limitations on Use of the Program.

**A. Personal Development Server.** The Personal Development Server is licensed for internal development and testing purposes only. The Personal Development Server is limited to use by single Standalone Seat with a connection limit of five (5) mobile devices. Deployment licenses for any purpose (including, without limitation, usage in a general production environment or on a web server) must be purchased from Sybase before you deploy any production components contained in the Program.

**B. Enterprise Development Server.** The Enterprise Development Server is licensed for internal development and testing purposes only. The Enterprise Development Server is limited to use by a single Standalone Seat with a connection limit of twenty (20) mobile devices. Deployment licenses for any purpose (including, without limitation, usage in a general production environment or on a web server) must be purchased from Sybase before you deploy any production components contained in the Program.

**C. Enterprise Server.** The Enterprise Server is licensed for use on a per Core basis with connection to Class A or Class B mobile devices, as applicable. The Enterprise Server license is based on (i) the number of Cores on which the Program is used, and (ii) the number of mobile devices to which the Program is connected. If you purchase a license for the Enterprise Server, you may use an unlimited number of mobile applications on each mobile device for which you are licensed.

**1. Terms Applicable to Enterprise Server – Single Application Client.** The Enterprise Server - Single Application Client is a limited use license which may be purchased in conjunction with an Enterprise Server license. If you purchase a license for the Enterprise Server – Single Application Client, you may only use one (1) mobile application on each mobile device for which you are licensed. If you wish to use more than one (1) mobile application per mobile device, you must purchase (i) additional licenses for the Enterprise Server –

Single Application Client, or (ii) upgrade to a full-use license for the Enterprise Server. Any and all use of the workflow container included in the Program counts as a single application.

**2. Terms Applicable to Enterprise Server - Annual Subscription.** Notwithstanding any terms to the contrary in the Sybase License Agreement, the Enterprise Server – Annual Subscription allows for deployment of the Program during a twelve (12) month license term. You must renew your annual subscription for the Program prior to any use of the Program beyond the twelve (12) month subscription term.

**IV. Distributable Files.** Sybase grants you a non-exclusive license to reproduce and distribute the "Distributable Files" in this version of Program in conjunction with mobile applications that you develop using the Program. The "Distributable Files" are those libraries within the Program that are identified in the documentation as useable during execution of your mobile application. THE DISTRIBUTABLE FILES ARE PROVIDED "AS IS" WITHOUT ANY WARRANTY WHATSOEVER. SYBASE DISCLAIMS ALL WARRANTIES AND CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, THE IMPLIED WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT, FITNESS FOR A PARTICULAR PURPOSE, AND CONDITIONS OF MERCHANTABILITY, WHETHER ARISING BY STATUTE OR IN LAW OR AS A RESULT OF A COURSE OF DEALING OR USAGE OF TRADE, WITH RESPECT TO THE DISTRIBUTABLE FILES. NEITHER SYBASE, NOR ITS SUBSIDIARIES NOR ANY OF ITS LICENSORS SHALL BE LIABLE FOR ANY DIRECT, INDIRECT, CONSEQUENTIAL OR INCIDENTAL DAMAGES (INCLUDING DAMAGES FOR LOSS OF BUSINESS PROFITS, BUSINESS LOSSES, BUSINESS INTERRUPTION, LOSS OF DATA, AND THE LIKE) ARISING OUT OF YOUR USE OR DISTRIBUTION OF THE DISTRIBUTABLE FILES, EVEN IF SYBASE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. Some jurisdictions do not allow the exclusion of implied warranties or the exclusion or limitation of certain damages, so the above exclusions may not apply to you.

**V. Restricted Use Components.** The Program contains or is provided with the Restricted Use Components identified below. You may Use the Restricted Use Components solely in conjunction with your use of the Program, and subject to any Additional Restrictions set forth below; provided that instead of utilizing Seat licenses of the SUP Program that you have purchased, you may use the SQL Anywhere and Mobilink Programs as part of a mobile application that you have developed, even if that mobile application is not developed using the SUP Program, and even if it does not interoperate with the SUP Program. For each Seat of a mobile application with which SQL Anywhere and Mobilink are used independent of the SUP Program, you shall be entitled to use one fewer Seat of the SUP Program, such that at no time shall the number of SUP Program Seats being used by you, plus the number of SQL Anywhere/Mobilink mobile application Seats being used by you exceed the number of SUP Program Seat licenses that you have purchased. If you elect to use SQL Anywhere and Mobilink in support of a mobile application as indicated above, you shall notify Sybase in writing, specifying the number of Seats for which this mobile application is being used. Such use of the SQL Anywhere and Mobilink Programs will otherwise be subject to the terms and conditions of the Sybase License Agreement, including these Product Specific License Terms.
