



## PRODUCT SPECIFIC LICENSE TERMS

### Software Developer Kit version 11.1.x-12.0.x End of Life Programs (each a "Program")

THE FOLLOWING TERMS SUPPLEMENT AND AMEND THE TERMS SET OUT IN THE SYBASE LICENSE AGREEMENT (INCLUDING THE PRODUCT SPECIFIC LICENSE TERMS APPLICABLE TO THE VERSION OF ASE THAT YOU PREVIOUSLY PURCHASED) ("AGREEMENT").

**AS TO COPIES OF THE PROGRAMS LICENSED AFTER JULY 30, 2006, THE TERMS AND CONDITIONS OF THESE PRODUCT SPECIFIC LICENSE TERMS MODIFY AND AMEND THE AGREEMENT.**

**LICENSING OF THE PROGRAMS IS RESTRICTED TO "QUALIFIED LICENSEES" (AS DEFINED BELOW).**

**ENGINEERING SUPPORT AND MAINTENANCE HAS BEEN DISCONTINUED FOR THE PROGRAMS ("END-OF-LIFE"). PLEASE REVIEW THE DETAILS BELOW CAREFULLY.**

- 1. Qualification as Licensee.** You are not authorized to purchase licenses for a Program unless you have previously purchased a license for the same version of the Program prior to July 30, 2006 ("Qualified Licensee"). If you are a Qualified Licensee, you are authorized to Use the additional number of copies of the Program set forth in the Order in accordance with the Agreement. You represent that you are a Qualified Licensee. If you have purchased a license for the Program after July 30, 2006 and you are not a Qualified Licensee, please contact Sybase immediately.
- 2. End-of-Life Programs.** Standard Sybase support and maintenance has been discontinued and is no longer available for the Programs. Sybase may in its discretion elect to make limited technical assistance available, subject to the availability and personnel and other resources, and subject to a separate Sybase support contract for such Programs on terms and conditions that must be agreed to between you and Sybase.
- 3. No Use of DataDirect Functionality.** Notwithstanding any provision of the Agreement, you may not use the DataDirect ODBC driver functionality included in the Program.
- 4. No Licensing of Programs After July 30, 2009.** You will not be able to obtain any additional copies of the Programs after July 30, 2009.
- 5. Additional Disclaimer of Warranties.** Notwithstanding any provision of the Agreement, the Programs and related Services, if any, are provided "AS-IS", WITH ALL FAULTS and WITHOUT ANY WARRANTY OR CONDITION OF WARRANTY.
- 6. Disclaimer of Indemnities.** Notwithstanding any provision of the Agreement, Sybase shall have no obligation to defend, indemnify or hold harmless you or any party for any claims arising out of, resulting from or in any way connected with a Program and/or your use of a Program, including but not limited to, claims of patent or copyright infringement or misappropriation of trade secrets.
- 7. Disclaimer of All Damages.** UNDER NO CIRCUMSTANCES SHALL SYBASE, ITS SUBSIDIARIES OR ITS LICENSORS BE LIABLE FOR DIRECT, INDIRECT, SPECIAL, EXEMPLARY, INCIDENTAL AND/OR CONSEQUENTIAL DAMAGES, INCLUDING, BUT NOT LIMITED TO, LEGAL FEES, LOSS OF PROFITS, LOSS OR INACCURACY OF DATA OR LOSS RESULTING FROM BUSINESS DISRUPTION, EVEN IF SYBASE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
