



PRODUCT SPECIFIC LICENSE TERMS

Unwired Accelerator version 8.x (“Program”)

IN ADDITION TO THE LICENSE TERMS SET OUT IN THE SYBASE LICENSE AGREEMENT, THE FOLLOWING ADDITIONAL OR DIFFERENT RIGHTS AND ACCOMPANYING OBLIGATIONS AND RESTRICTIONS SHALL APPLY TO THE PROGRAM FOR WHICH YOU HAVE PURCHASED A LICENSE.

The Program may contain or be provided with component software products from both Sybase and third parties. Except as set forth below, use of all components is limited to use in the same manner and capacity for which the Program as a whole is licensed. Additional licenses for Sybase components may be available from Sybase for a fee.

I. Named User License. If the Program is designated as an “OT” license type, as indicated in the applicable Exhibit A or Purchase Order, Customer is authorized to Use the server component of the Program on a single Machine (use of the server component of the Program on additional Machines requires the purchase of additional licenses), and to permit Use of the client component of the Program solely by Named Users to access the server component of the Program via a public (including the Internet) or private network; provided that at no time shall the number of Named Users exceed the number of “Named User” licenses purchased by Customer. As used herein, the term “Named User” means a single, specific named person who is authorized by Customer to Use the client component of the Program to access the server component of the Program.

II. Sybase Restricted Use Components. The Program contains or is provided with the Restricted Use Components identified below. Customer is licensed without further charge to Use only one (1) copy of each Restricted Use Component on one (1) Machine. Customer may Use the Restricted Use Components solely in conjunction with Customer’s use of the Program, and subject to any Additional Restrictions set forth below.

Any obligations undertaken by Sybase in the Agreement relating to the Free Download Components as part of the Program are provided by Sybase alone, and not by the third party licensors of the Free Download Components. **1.
